IMPORTANT CIRCULAR

All Principals/Directors of Medical Colleges/ Government Institutions and Heads of the Non-Government Affiliated Institutions, are hereby informed that as per the Resolution adopted by the Board of Studies of the State Medical Faculty of West Bengal, at their meeting held on 28.04.2022 **the eligibility criteria for appearing in any examination of Para Medical Courses by any student is (i) 75% Attendance in classes, and, (ii) Passing in Internal Assessment, both in Theory/ Practical/Oral & Practical from the year 2022 onwards.**

Hence, students of any Para Medical Course for appearing in Preliminary/Final Examination – August, 2024, should take a note of the following:-

1] Re: Internal Assessment:

50% pass marks, individually in Theory, Practical and in Oral & Practical, would need to be obtained by a student to be eligible for appearing at the examinations. The students, who would obtain marks below 50% in Internal Assessment, would not be sent up for appearing at the examinations by the Institute.

Marks obtained in Internal Assessment by a student would not be incorporated as a component for adding to Pass Mark of any individual subject/paper, nor the same be shown in the Mark Sheet of the student.

The students, who would obtain the qualifying 50% or more marks in Internal Assessment, would need to be declared by the concerned Institute as "Passed", and, names of such students are to be submitted in the prescribed Slip Rolls, issued by the Faculty Office, **within June, 2024 positively** to enable the Faculty Office to issue Admit Cards in time for them.

2] Re: Attendance:

Minimum 75% attendance is required to be secured by a student for appearing at the examinations.

However, for attendance percentage secured by a student between 60 and 74%, a fine of Rs.2000/- per examination per course is to be paid by such a student for appearing at the examinations at the Faculty Office.

Students with attendance percentage below 60% are not allowed to appear at the examinations.

All Principals/Directors of Medical Colleges/ Government Institutions and Heads of the Non-Government Affiliated Institutions, are requested to kindly be so good as to arrange for circulation of this Notice at all concerned.
